 - (c) The Society’s Constitution shall always remain consistent with the Constitutions of AFIC and its State Council.
 - (d) The Society will pay an annual membership fee to AFIC and its State Council as determined from time to time by the Federal Council.
 - (e) The Society will not enroll any member of another society which is a member of AFIC and its State Council.
 - (f) As a constituent member of AFIC and its State Council, the Society will abide by any directive from AFIC and its State Council and if it fails to do so, it may be expelled as a member of AFIC and its State Council.
