



## **QUEENSLAND MUSLIM UNITY CUP ANNUAL SOCCER TOURNAMENT - 2020**

### **TOURNAMENT RULES AND INDEMNITY**

1. Players can register and represent one team only.
2. Players must be 16 years or older.
3. Covid-19 restrictions apply and must be followed at all times.
4. The tournament organisers are not responsible for any loss of personal belongings or valuables.
5. Players, manager and coaches are responsible for their own safety and indemnify the organisers against any personal injuries
6. A maximum of 16 players per registered team - NO EXCEPTIONS.
7. Registration fee is \$25 per player - fees must be paid via direct transfer to the ICQ bank account upon registration - BSB 034013 ACC # 510216
8. A player found representing more than one team will be disqualified from the tournament and the offending team will lose its points for that game, if applicable.
9. Any protest must be lodged in writing within one hour of game end with a \$100 fee - refundable only if protest is successful.
10. All players must be properly attired for all games.
11. Non-Muslim players affiliated to an Islamic organisation are eligible for registration.
12. Any player that receives a RED card will be suspended for the next game.
13. Any player receiving 2 YELLOW cards will be suspended for the next game.
14. Let your participation in this tournament be a reflection of our Islamic values.
15. No drugs or alcohol permitted at the venue.
16. Teams must be ready for kick-off as per arranged start times.
17. If teams are equal on points and goal difference to decide pool winner, the winner will be decided by the toss of a coin.
